do hereby agree and undertake in favour of Redpoint Club, its management committee, members and agents (herein referred to as "the Club") that:

1. I am the legal guardian of the abovementioned minor and have the necessary legal authority to complete and sign this contract.

I confirm that the abovementioned minor is participating in the Club activities with my full consent, and that I am aware that participation in rock climbing, bouldering, mountaineering, hiking, scrambling, and activities incidental thereto to which my abovementioned child/ward may be exposed as a result of his/her participation in activities organized by or on behalf of the Club, entail significant risks which could result in physical or emotional injury, disability or death, or damage to property. Such risks include, among others, climber falling badly, equipment failure, falling objects, and negligence of belayers and other participants. I understand and accept that my abovementioned child/ward's participation in any such activities is at his/her and my own risk, for which I accept all responsibility.
3. I, accordingly, hereby irrevocably waive, relinquish and abandon all claims of any nature whatsoever which I may have against the Club or any of its members or agents, arising out of my abovementioned child/ward's participation in club activities and activities organized by or on behalf of the Club, for loss or damage to property, personal injury or loss of life, howsoever caused and irrespective of whether the loss or damage occurred as a result of negligence (excluding gross negligence).
4. I agree to indemnify the Club and any of its members or agents against any claim which may be brought against them arising out of my abovementioned child/ward's participation in club activities and activities organized by or on behalf of the Club, for loss or damage to property, personal injury or loss of life, howsoever caused and irrespective of whether the loss or damage occurred as a result of negligence (excluding gross negligence).
5. I confirm that my abovementioned child/ward is physically and psychologically fit to participate in the activities of the Club, and that I have declared in the Club's Application of Membership form any medical or psychological conditions, allergies or medications that might affect his/her health / safety or enjoyment of the Club activities, and of which a person co-ordinating the Club activities in which he/she participates should be aware.
6. Should my abovementioned child/ward be injured whilst participating in club activities or activities organized by or on behalf of the Club, I hereby appoint and authorise the person who is co-ordinating the activity for or on behalf of the Club to consent to his/her undergoing surgical or other medical treatment which in the opinion of the attending medical practitioner is necessary and should it not be reasonably possible to obtain my consent timeously. I further undertake to pay the cost of such treatment.
7. I agree that my abovementioned child/ward will abide by the rules of the Club as decided from time to time by the Club's Management Committee.
8. I agree that the terms and conditions contained herein will remain binding upon me, my heirs, executors, administrators and assigns.
